

BEAU MONDE VILLAS BY NATURAL RETREATS FESTIVAL PASS GIVEAWAY TERMS AND CONDITIONS

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. Promotion Description: The Desert Trip Weekend 1 Passes Sweepstakes ("Sweepstakes") begins on 10/6/2016 at 4:00 PM (Pacific Time (US & Canada)) and ends on 10/7/2016 at 12:00 AM (Pacific Time (US & Canada)) (the "Promotion Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Beau Monde Villas by Natural Retreats ("Sponsor"), which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the giveaway. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes.
2. Eligibility: Open to legal residents of USA who must be 21 years or older. Void where prohibited or restricted by law.
